

Photography Policy

We love to share our farm with our community! And what better way to share our beautiful farm land than to allow professional photographers the ability to capture special moments on camera! Making lasting memories on the farm is priceless! This photography policy applies to all photographers that have paid for a Pingle's Photographer Pass and have a confirmation date and time. All professional photography sessions must be pre-booked online through Pingle's booking site and fully paid.

A photographer that would like to use Pingle's farm as a backdrop or setting for commercial use, usually for compensation but is considered professional regardless of financial compensation or otherwise, in the form of commercial, portrait, or landscape photography, would fall into this category.

- Portrait photography is defined as, but not limited to: senior, engagement, family, graduation, wedding, etc.
- Commercial photography is defined as, but not limited to: catalog, fashion, advertisement, promotion, etc.

This photography is ONLY permitted with the purchase of a photographer's pass. As such, pass holders agree to the following terms and conditions set forth for Pingle's Farm Market located at 1805 Taunton Road East in Hampton, Ontario L9L 1B5:

Pingle's Is A Working Farm

Please remember Pingle's is a working farm. We cannot predict or control weather. We cannot predict the timing of blossoming and blooming. Harvesting and fruiting, insects and disease control of the crops do not always cooperate with our human wants and intentions. We may have to reschedule dates due to these factors that are beyond our control.

The use of chemical applications on Pingle's Farm property is routinely necessary and we need to follow all governmental guidelines for human entry to keep everyone safe. As a result, this may restrict areas that you and your clients may enter. It is imperative that you follow all signage and stay in the designated areas.

At no time is the photographer or his/her client(s) allowed on any of the farm's equipment (tractors, gators, sprayers, ladders, lawnmowers, or any other equipment). This will be cause for immediate removal off of the property.

Please respect our natural environment and the crops we are growing. Pingle's farm reserves the right to cancel the booking due to events beyond our control. Every effort will be made to reschedule, and if not, all booking fees will be refunded.

Timing

The photographer and his/her clients are to remain on the property only during their designated session times.

Absolutely NO sessions after business hours

Locations

Stay in the designated areas during all your photo shoots.

There is absolutely no access to any non-public farm buildings. Do not wander and stay on the marked walkways and areas.

Please leave the area of your photo as you found it.

Electrical Usage

Electrical hook-ups and power supplies are not available.

Smoking, Vaping, and Alcohol Prohibited

Smoking cigarettes, cigars, marijuana or any other smoking apparatus including vaping is strictly prohibited throughout the entire acreage of Pingle's Farm Market. This means all buildings, all outdoor areas, and parking lot. Smoking is permitted inside personal vehicles and must be extinguished in the vehicle to avoid littering.

Picking of Crops

Please refrain from picking crops including flowers for prop use unless you have paid for the crops. This is considered theft.

Other Restrictions

- Vehicles are NOT allowed in the general admission area under any circumstances.
- All props, must be carried to the photoshoot location. Props or equipment that cannot be carried easily should not be used.
- All props must be removed upon departure.
- Pick up all trash and dispose of garbage in the appropriate and designated refuse bins.
- The use of drones is strictly prohibited
- All photos should be family friendly in nature.
- Pingle's Farm reserves the right to halt any photography sessions deemed to be disruptive.
- Pingle's Farm assumes no responsibility for loss, theft, or damage to any equipment or belongings.
- Any unauthorized portrait/commercial photography sessions will be stopped immediately and the photographer will be asked to vacate the premises.
